

# English as an Additional Language (EAL) Policy To include EYFS

Sherrardswood School

#### 1. Introduction

In our school, all our children are important, and this applies to all aspects of their education – their teaching and learning, their achievements, their attitudes and their well-being. We encourage all our children to aim for the highest possible standards, and we take account of each child's individual needs and experiences.

A number of our children have particular requirements with regard to learning and assessment, and these are linked to their progress in learning English as an additional language.

Children who are learning English as an additional language have linguistic skills similar to those of monolingual English-speaking children. Their ability to participate in the full curriculum may well be in advance of their current ability to communicate in English. Equally learning difficulties may exist in English as well as non-English speaking children.

Being a speaker of more than one language is no disadvantage to educational achievement; indeed, multilingualism is associated with success. This school recognises the importance of community languages in their own right, and the ability of their speakers to acquire other languages.

## 2. Aims and Objectives

Underlying the National Curriculum is the entitlement of all children to access certain areas of learning, and thereby to acquire the knowledge, the understanding, the skills and the attitudes that are necessary not only for their self-fulfilment, but also for their development as responsible citizens. We seek to honour this entitlement through the education that we provide in our school.

The aim of this policy is therefore to help to ensure that we meet all the needs of those children who are learning English as an additional language. This is in line with the requirements of the Race Relations Act 1976.

### 3. Teaching and Learning Style

In our school teachers use various methods to help children who are learning English as an additional language, developing their spoken and written English by:

- Working with parents to ensure that they are fully developing and utilising a wider vocabulary, expression etc within their own mother tongue is the best way to extend and develop the English language
- Ensuring that vocabulary work covers the technical as well as the everyday meanings
- Covering not just key words, but also metaphors and idioms
- Explaining how spoken and written English have different usages for different purposes
- Providing them with a range of reading materials, to exemplify the different ways in which English is used
- Giving them appropriate opportunities for talking, and using talking to support writing
- Providing specialised courses in phonics, reading and spelling as necessary

Ensuring their access to the curriculum and to assessment by:

- Using texts and materials that suit their ages and learning stages
- Providing support through ICT, video and audio materials, dictionaries and translators, readers and amanuenses
- Using the home or first language where possible and appropriate

#### 4. EAL and Inclusion

In our school, we value each child as a unique individual. We will strive to meet the needs of all our children. We provide learning opportunities that enable all pupils to make good progress. We strive hard to meet the needs of all pupils learning English as an additional language, and we take all reasonable steps to achieve this.

In the Foundation Stage, we provide opportunities for children to develop their English, and we provide support to help them take part in activities by:

- Building on their experience of acquiring language at home and in the wider community, so that this experience supports their developing use of English
- Providing a range of opportunities for them to engage in English speaking and listening activities, with peers and with adults

# 5. Assessment for Learning

The statutory assessment arrangements of the National Curriculum allow us to make special arrangements for children who are learning English as an additional language.

In the mathematics tasks and tests at Key Stage 1, we help EAL children by translating English words or phrases in the assessment materials, or non-English words or phrases that the children use in their responses.

For the written mathematics test at Key Stage 2, we provide verbal or written translations of words or phrases in the test papers which we think are likely to prove difficult to children for whom English is an additional language. For the mental arithmetic test at Key Stage 2, we provide a verbal translation of the test to children who have limited English.

Students in the Senior school that have EAL are entitled to a word for word bilingual translation dictionary. This, however, may not be used in GCSE English Language/Literature, Geography, History or modern foreign languages if testing one of the languages of the actual dictionary or a similar language eg. Spanish/Portuguese. If extra time is considered to be needed then this needs to be applied for by the SENCo in the same way as any other access arrangement.

For internal examinations, depending on the level of need, students will be offered the use of; a translation dictionary, an electronic translator, verbal or written translation or explanation of words or phrases.

#### 6. Monitoring and Review

This policy is monitored by the head teacher, and will be reviewed in two years, or earlier if necessary.
